The candidate whose final result is awaited are also allowed to take admission provisionally, subject to submission of final mark/grade card (fulfilling the minimum eligibility criteria) and pass certificate on or before 15<sup>th</sup> September, 2021, failing which the admission shall be treated cancelled automatically.

All the original documents will be verified at the time of physical reporting to the institute. If any document is found to be falsified, admission will automatically stand cancelled and the admission fee paid will be forfeited.
